Description of Change:

Cypress announces the qualification of Amkor Technology Philippines (ATP) as an additional assembly site for select 20-Pin Small Outline Integrated Circuit (SOIC), 300 mils body, Pb-Free products. These products are ROHS and REACH compliant.

The 20-Pin SOIC, 300 mils body, Pb-Free packages are assembled at ATP using the following Bill of Materials:

Approximate Implementation Date:

Effective 90 days from the date of this notification, all shipments of the affected part numbers in the attached file will be assembled at ATP or other approved assembly sites.

Anticipated Impact:

Products assembled at the new site are completely compatible with existing products from form, fit, functional, parametric, and quality performance perspectives.

Cypress also recommends that customers take this opportunity to review these changes against current application notes, system design considerations and customer environment conditions to assess impact (if any) to their application.

Method of Identification:

Cypress maintains traceability of product to wafer level, including wafer fabrication location, through the lot number marked on the package.
